Drinking Water Consumer Confidence Report For 2016

Introduction

Scioto Water, Inc. has prepared the following report to provide information to you, the consumer, on the quality of our drinking water. This report is required as part of the Safe Drinking Water Act Reauthorization of 1996 and is required to be delivered to the consumers by July 1, 2017. Included within this report are general health information, water quality test results, how to participate in decisions concerning your drinking water and water system contacts. This report covers the quality of the water produced at the Treatment Plant for the Rose Hill water system, and also the water purchased from Scioto County Regional Water District #1.

Source of Water Information

The Rose Hill Public Water System (PWSID #7300303) of Scioto Water, Inc. receives its drinking water from ground wells that pump from the Scioto River Valley Aquifer. Scioto Water, Inc. currently has five (5) production wells in operation in our twenty-five (25) acre well field located in the Scioto River Valley. The well field is located approximately one fourth of a mile west of our Treatment Plant located at 1973 Fairground Road in Lucasville, Ohio. Scioto Water, Inc. also has an auxiliary connection and purchases additional water for this system from Scioto County Regional Water District #1 (Water 1). Water purchased from Water 1, also comes from wells that pump from the Scioto River Valley Aquifer. Maps of the Rose Hill System are on file at the treatment plant in Lucasville and at the main office in Franklin Furnace, and can be viewed during normal business hours of 8:00 a.m. to 4:00 p.m.

The Davis Camp Public Water System (PWSID #7302503), owned and operated by Scioto Water, Inc. is supplied from water purchased from Scioto Co. Regional Water District #1. Their source water comes from nine wells located in the Scioto River Valley Aquifer near St. Rt. 348. Their main office is located at 326 Robert Lucas Rd. Lucasville Ohio. What are sources of contamination to drinking water?

The sources of drinking water both tap water and bottled water includes; rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include: (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife; (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses; (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems; (E) radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Who needs to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infection. These people should seek advice about drinking water from their health care providers. About your Drinking Water

The EPA requires regular sampling to ensure drinking water safety. Scioto County Regional Water District #1 and Scioto Water, Inc. constantly monitor and sample the water before, during, and after the water is processed to insure water quality. Along with those listed below, we have conducted sampling and tested for bacteria; inorganic; radiological; synthetic organic; and volatile organic contaminants. The Ohio EPA requires us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, are more than one year old.

Source Water Information

High Susceptibility PWS Based on High Sensitivity

Ohio EPA completed a study of Scioto Water, Inc. - Rose Hill source of drinking water, to identify potential contaminant sources and provide guidance on protecting the drinking water source. According to this study, the aquifer (water-rich zone) that supplies water to Scioto Water, Inc. - Rose Hill has a high susceptibility to contamination.

This is based on the following:

- : **The presence of a relatively thin protective layer of silty loam overlying the aquifer;**
- : **A shallow depth (less than 15 feet below ground surface) of the aquifer;**
- : **The presence of significant potential contaminant sources in and just beyond the protection area.**

This susceptibility means that under currently existing conditions, the likelihood of the aquifer becoming contaminated is relatively high. This likelihood can be minimized by implementing appropriate protective measures. High Susceptibility PWS Based on High Sensitivity

Ohio EPA completed a study of Scioto County Regional Water Authority's source of drinking water, to identify potential contaminant sources and provide guidance on protecting the drinking water source. According to this study, the aquifer (water rich zone) that supplies water to the water district has a high susceptibility to contamination. This determination is based on the following:

- the presence of a relatively thin protective layer of soil overlying the aquifer;**
- the depth to water in the aquifer is 10 to 15 ft below the ground surface;**
- the presence of numerous and significant potential contaminant sources in the protection area**

This susceptibility means that under currently existing conditions, the likelihood of the aquifer becoming contaminated is relatively high. This likelihood can be minimized by implementing appropriate protective measures. Definitions of some terms contained within this report.

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Below Detectable Limits (BDL): Contaminant not detected using the standards approved by E.P.A.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Parts per Million (ppm) or Milligrams per Liter (mg/L) are units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.

Parts per Billion (ppb) or Micrograms per Liter (µg/L) are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.

Action Level Goal (ALG): The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Treatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

The “<” symbol: A symbol which means less than. A result of <5 means that the lowest level that could be detected was 5 and the contaminant in that sample was not detected.

Picocuries per liter (pCi/L): A common measure of radioactivity.
